OUR UNDERSTANDING

Florida Department of Children and Families / Adoptions (DCF) has requested assistance from Image API (IAPI) to decrypt 165 DVDs containing closed adoption records.

IAPI is the sole developer and service provider for the decryption application.

OUR APPROACH

IAPI will complete the following activities to perform the decryption services:

- Develop the decryption application based upon proprietary software
- Capture digital adoption records from DVDs
- Extract metadata from current format
- Convert the unencrypted images into multi-page PDFs based on document type as indicated in the metadata
- Return the original DVDs to DCF upon completion of the decryption services
- Upon completion of the decryption process, provide DCF with unencrypted images and metadata in an agreed electronic format

PRICING

Pricing is based upon assumptions listed below. Services fees will be invoiced upon delivery of the unencrypted records to DCF.

Key Assumptions

- The number of images on the 165 DVDs for decryption is estimated to be 1.5M
- IAPI and DCF will mutually agree upon a timeline. As a general guideline, the project timeline can begin once IAPI receives a purchase order
- Digital images on the DVDs are in single page TIFF format
- Prior to project start, DCF will provide a master repository database, including a unique identifier, to validate index elements

- Master repository database will be provided in a mutually agreed upon format
- Decryption services will be completed at the IAPI facility located in Tallahassee, FL
- Unencrypted records will be delivered on an encrypted hard drive at completion of effort
- Files or images that cannot be matched in the master repository will be decrypted, but not added to the resultant metadata repository

CHANGE CONTROL

IAPI recognizes the importance of containing scope, and managing and tracking changes to that scope. It is the intent to always try to resolve issues within the bounds of the current SOW and scope/level of effort. If this is not possible, upon mutual agreement, a formal Project Change Request (PCR) form will be presented to DCF.
