This Contract is between the State of Florida, Department of Management Services (Department), an agency of the State of Florida and XXXXXXXXXXXXXXXXXXXX (Contractor).

The Contractor submitted a response to the Department’s solicitation, RFP No. 07-44111513-K for Office Supplies. After evaluation of proposals, the Department has determined that the Contractor’s proposal provides a best value to the State of Florida.

Accordingly, the Department and Contractor agree as follows:

Initial Contract Term

The Initial Contract Term will be for five (5) years. The Initial Contract Term shall become effective on November 15, 2016 and expire on November 14, 2021.

Renewal Term(s)

Upon mutual written agreement, the Department and the Contractor may renew this Contract, in whole or in part, for a Renewal Term not to exceed the Initial Contract Term of five (5) years, pursuant to the incorporated General Contract Conditions.

Contract

As used in this document, the term “Contract” (whether or not capitalized) shall, unless the context requires otherwise, be considered to be references to this Contract, including all Exhibits attached, which set forth the entire understanding of the Parties and supersedes all prior agreements, whether written or oral, with respect to such subject matter.
